4. FIRST AID MEASURES

General Information : Not expected to be a health hazard when used under normal conditions.

5. FIRE FIGHTING MEASURES

Glove thickness is not a good predictor of glove resistance to a chemical as it is dependent on the exact composition of the glove material.
