### 2. HAZARDS IDENTIFICATION

NON-HAZARDOUS SUBSTANCE. NON-DANGEROUS GOODS.

Not classified as hazardous according to the criteria of NOHSC, and not classified as Dangerous Goods according to the Australian Dangerous Goods Code.

<b>Health Hazards</b>	: Not expected to be a health hazard when used under normal conditions. Prolonged or repeated skin contact without proper cleaning can clog the pores of the skin resulting in disorders such as oil acne/folliculitis. High-pressure injection under the skin may cause serious damage including local necrosis. Used grease may contain harmful impurities.
<b>Signs and Symptoms</b>	: Local necrosis is evidenced by delayed onset of pain and tissue damage a few hours following injection. Oil acne/folliculitis signs and symptoms may include formation of black pustules and spots on the skin of exposed areas. Ingestion may result in nausea, vomiting and/or diarrhoea.
<b>Safety Hazards</b>	: Not classified as flammable but will burn.
<b>Environmental Hazards</b>	: Harmful to aquatic organisms, may cause long-term adverse effects in the aquatic environment.

**Additional Information** : Antimony content of the blended product is <0.25%. The highly refined mineral oil contains <3% (w/w) DMSO-extract, according to IP346. Refer to chapter 16 for full text of EC R-phrases.

#### 4. FIRST AID MEASURES

- General Information** : Not expected to be a health hazard when used under normal conditions.
- Inhalation** : No treatment necessary under normal conditions of use. If symptoms persist, obtain medical advice.
- Skin Contact** : Remove contaminated clothing. Flush exposed area with water and follow by washing with soap if available. If persistent irritation occurs, obtain medical attention. When using high pressure equipment, injection of product under the skin can occur. If high pressure injuries occur, the casualty should be sent immediately to a hospital. Do not wait for symptoms to develop. Obtain medical attention even in the absence of apparent wounds.
- Eye Contact** : Flush eye with copious quantities of water. If persistent irritation occurs, obtain medical attention.
- Ingestion** : In general no treatment is necessary unless large quantities are swallowed, however, get medical advice.
- Advice to Physician** : Treat symptomatically. High pressure injection injuries require prompt surgical intervention and possibly steroid therapy, to minimise tissue damage and loss of function. Because entry wounds are small and do not reflect the seriousness of the underlying damage, surgical exploration to determine the extent of involvement may be necessary. Local anaesthetics or hot soaks should be avoided because they can contribute to swelling, vasospasm and ischaemia. Prompt surgical decompression, debridement and evacuation of foreign material should be performed under general anaesthetics, and wide exploration is essential.

#### 5. FIRE FIGHTING MEASURES

Clear fire area of all non-emergency personnel.

- Specific Hazards** : Hazardous combustion products may include: A complex mixture of airborne solid and liquid particulates and gases (smoke). Carbon monoxide. Unidentified organic and inorganic compounds.
- Suitable Extinguishing Media** : Foam, water spray or fog. Dry chemical powder, carbon dioxide, sand or earth may be used for small fires only.

### 6. ACCIDENTAL RELEASE MEASURES

- Clean Up Methods** : Shovel into a suitable clearly marked container for disposal or reclamation in accordance with local regulations.

### 7. HANDLING AND STORAGE

- General Precautions** : Use local exhaust ventilation if there is risk of inhalation of vapours, mists or aerosols. Properly dispose of any contaminated rags or cleaning materials in order to prevent fires. Use the information in this data sheet as input to a risk assessment of local circumstances to help determine appropriate controls for safe handling, storage and disposal of this material.
- Handling** : Avoid prolonged or repeated contact with skin. Avoid inhaling vapour and/or mists. When handling product in drums, safety footwear should be worn and proper handling equipment should be used.
- Storage** : Keep container tightly closed and in a cool, well-ventilated place. Use properly labelled and closeable containers. Storage Temperature: 0 - 50 °C / 32 - 122 °F
- Recommended Materials** : For containers or container linings, use mild steel or high density polyethylene.
- Unsuitable Materials** : PVC.
- Additional Information** : Polyethylene containers should not be exposed to high temperatures because of possible risk of distortion.

- Additional Information** : Due to the product's semi-solid consistency, generation of mists and dusts is unlikely to occur.

- Exposure Controls** : The level of protection and types of controls necessary will vary depending upon potential exposure conditions. Select controls based on a risk assessment of local circumstances. Appropriate measures include: Adequate ventilation to control airborne concentrations. <b>Reproductive and Developmental Toxicity</b>	: Not expected to be a hazard.
<b>Additional Information</b>	: Used grease may contain harmful impurities that have accumulated during use. The concentration of such harmful impurities will depend on use and they may present risks to health and the environment on disposal. ALL used grease should be handled with caution and skin contact avoided as far as possible. High pressure injection of product into the skin

may lead to local necrosis if the product is not surgically removed.

### 12. ECOLOGICAL INFORMATION

Ecotoxicological data have not been determined specifically for this product. Information given is based on a knowledge of the components and the ecotoxicology of similar products.

- Acute Toxicity** : Poorly soluble mixture. May cause physical fouling of aquatic organisms. Expected to be harmful: LL/EL/IL50 10-100 mg/l (to aquatic organisms) (LL/EL50 expressed as the nominal amount of product required to prepare aqueous test extract).
- Mobility** : Semi-solid under most environmental conditions. Floats on water. If it enters soil, it will adsorb to soil particles and will not be mobile.
- Persistence/degradability** : Expected to be not readily biodegradable. Major constituents are expected to be inherently biodegradable, but the product contains components that may persist in the environment.
- Bioaccumulation** : Contains components with the potential to bioaccumulate.
- Other Adverse Effects** : Product is a mixture of non-volatile components, which are not expected to be released to air in any significant quantities. Not expected to have ozone depletion potential, photochemical ozone creation potential or global warming potential.
