2. HAZARDS IDENTIFICATION

EC Classification	:	Not classified as dangerous under EC criteria.
Health Hazards	:	Not expected to be a health hazard when used under normal conditions. Prolonged or repeated skin contact without proper cleaning can clog the pores of the skin resulting in disorders such as oil acne/folliculitis. Used oil may contain harmful impurities.
Signs and Symptoms	:	Oil acne/folliculitis signs and symptoms may include formation of black pustules and spots on the skin of exposed areas. Ingestion may result in nausea, vomiting and/or diarrhoea.

- and follow by washing with soap if available. If persistent irritation occurs, obtain medical attention.
- Eye Contact** : Flush eye with copious quantities of water. If persistent irritation occurs, obtain medical attention.
- Ingestion** : In general no treatment is necessary unless large quantities are swallowed, however, get medical advice.
- Advice to Physician** : Treat symptomatically.

5. FIRE FIGHTING MEASURES

- Exposure Controls** : The level of protection and types of controls necessary will vary depending upon potential exposure conditions. Acute Toxicity	: Poorly soluble mixture. May cause physical fouling of aquatic organisms. Mineral oil is not expected to cause any chronic effects to aquatic organisms at concentrations less than 1 mg/l.
